## **BURSARY OPPORTUNITIES FOR TVET STUDENTS IN NATIONAL VOCATIONAL CERTIFICATE PROGRAMMES AND NATED (REPORT 191) PROGRAMMES**

- Students who are between the ages of 16 and 35 years of age
- Students must be South African citizens
- Students must have no criminal record or pending criminal cases against them

Applications will be evaluated, and a selection process will take place by the Executive Management Team at Future Managers.
